<b>SECTION 2 - HAZARDS IDENTIFICATION</b>

Other Ingredients: Water, Sodium Lauryl Sulfate, Sodium Laureth Sulfate, Glycol Distearate, Zinc Carbonate, Sodium Chloride, Sodium Xylenesulfonate, Fragrance, Cocamidopropyl Betaine, Dimethicone, Sodium Benzoate, Guar Hydroxypropyltrimonium Chloride, Magnesium Carbonate Hydroxide, Propylene Glycol, Citrus Limon (Lemon) Fruit Extract, Methylchloroisothiazolinone, Methylisothiazolinone, Yellow 5, Blue 1.

The product(s) does not contain ingredients considered hazardous as defined by OSHA, 29 CFR 1910.1200 and/or WHMIS under the HPA.

### SECTION 4 - FIRST AID MEASURES

• **Eye:**
